TO DATE, THERE HAVE BEEN 53 FAMILIES AND 87 CHILDREN WHO HAVE LOST A PARENT WHOSE HOME OF RECORD WAS MASSACHUSETTS. THESE CHILDREN ARE ELIGIBLE TO RECEIVE EDUCATIONAL GRANTS FROM THE MSLF. CURRENTLY, THESE CHILDREN'S AGES RANGE FROM AGE 4 TO 34 YEARS OF AGE. THE MSLF DISTRIBUTES GRANTS TO ELIGIBLE CHILDREN FOR HIGHER EDUCATION, EDUCATIONAL AND VOCATIONAL PROGRAMS, PRE AND POST-SECONDARY EDUCATION. IN 2022, THE MSLF DISTRIBUTED A TOTAL OF \$375,371 IN GRANTS FOR THE BENEFIT OF THESE CHILDREN.

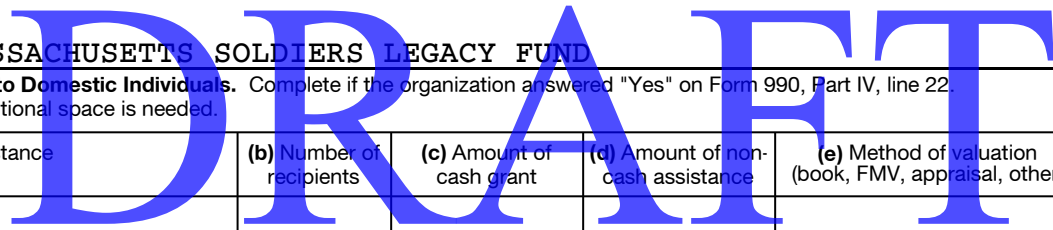
