TO DATE, THERE HAVE BEEN 86 CHILDREN WHO HAVE LOST A PARENT WHOSE HOME OF RECORD WAS MASSACHUSETTS. THESE CHILDREN ARE ELIGIBLE TO RECEIVE EDUCATIONAL GRANTS FROM THE MSLF. CURRENTLY, THESE CHILDREN'S AGES RANGE FROM AGE 2 TO 32 YEARS OF AGE. THE MSLF DISTRIBUTES GRANTS TO ELIGIBLE CHILDREN FOR HIGHER EDUCATION, EDUCATIONAL AND VOCATIONAL PROGRAMS, PRE AND POST-SECONDARY EDUCATION. IN 2020, THE MSLF DISTRIBUTED A TOTAL OF \$430,580 IN GRANTS FOR THE BENEFIT OF THESE CHILDREN.
